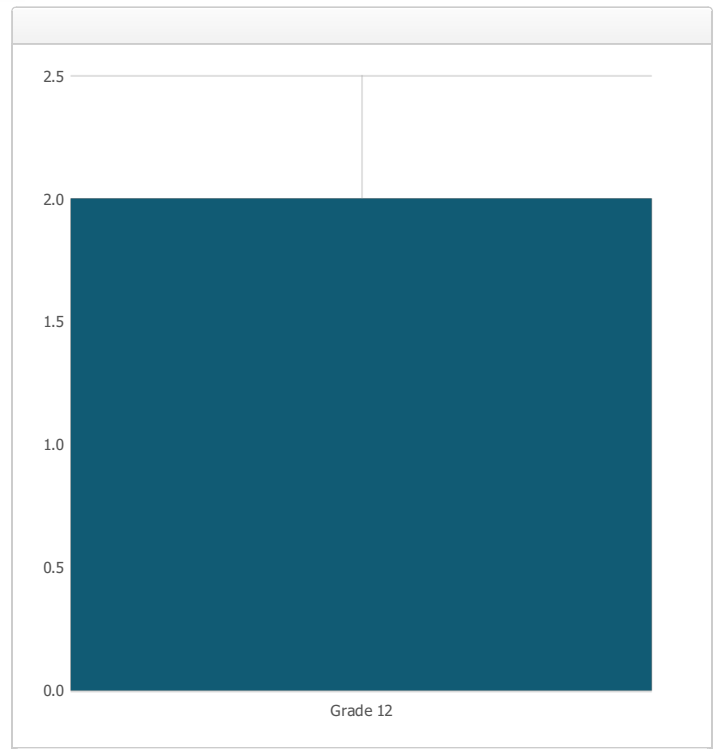
Earle Jamieson Educational Options is actually made up of 2 schools, Launch and Edge Academy. Launch is a 7-12 grade County Community School.

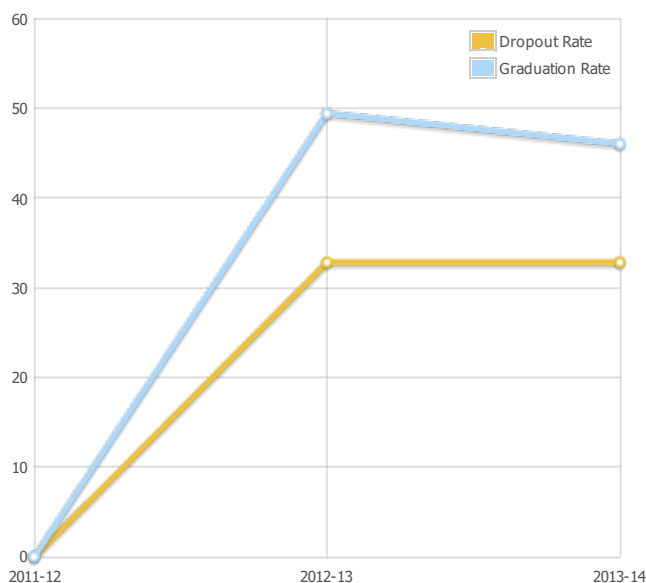
