Teena Corker walked the board through and explained details of the ESSER III Expenditure Plan document which runs through 3 fiscal years.

Johnson noted the importance of the funding in helping to bridge the learning gap from 2020. However, questioned how execution would take place as across the state there's lack of personnel. Corker acknowledged the challenge; NCSOS is hoping by increasing hours in existing positions staff will come forward. In addition, districts and charters are being creative in solutions, including looking at online opportunities and contracting with private vendors where possible.
