7. Superintendent's Report

The CDE's JPA Food Services submission process requires participating governing board minutes indicating approval of the agreement. NCSOS's participation is minimal, however the signed agreement is included here out of concern to not hold up the approval process for the districts.

Supt. Lay addressed school safety, noting that over the years NCSOS has developed a collaborative and cooperative partnership with local law enforcement, fire, and Nevada County Office of Emergency Services. The Community Agencies United for Safe Schools and Safe Streets (CAUSSSS) committee continues to bring school administrators, law enforcement, local first responders, and supporting agencies together monthly to discuss the climate of our County. Concerns affecting students are addressed and recommendations are shared. This partnership allows for open communication, cooperation, and sharing of ideas regarding emergency preparedness and crisis planning.

It was also noted that in an abundance of caution, additional security personnel will be present during graduations this year. Districts have their own way of communicating school safety plans directly to parents and students as each school has different needs and communication systems. Staff are continually trained; and drills are held at each school. Chris Espedal, NCSOS Director of School Safety, will join an upcoming Nevada County Board of Education meeting to give a presentation on school safety in Nevada County.

Schools are ending on a positive note with graduations. Some have taken place already, while others are upcoming. Supt. Lay, Teena Corker, and some board members have attended, or are planning to attend, several graduations, including Forest Charter, Bitney, Clear Creek, and North Point Academy.
